# Plus Europe operates across the continent as a civic network



The Plus Europe Organization operates through several organs:

- 1. The Plus Europe Association is a registered entity. Its President is also the Secretary General of The Plus Europe Conference Organizing Committee.
- 2. The General Secretariat provides support and coordination to the European Organizing Committee (EUROCOM), the National Committees (NATCOMs) and the Advisory Board.
- 3. The European Organizing Committee (EUROCOM) is formed by the Presidents of each NATCOM. It decides where the Annual Plus Europe Conference will take place and also which Working Documents and Recommendations will be presented to European Institutions.
- 4. The National Committee (NATCOM) of each European country has a President and up to nine members made up of academics, entrepreneurs, professionals as well as other civic personalities.
- 5. The Advisory Board assists the EUROCOM and the General Secretariat in defining its long term strategies and proposes the Working Documents and Recommendations to be submitted to European Institutions in hopes of future implementation. These proposals are related to the domains of Free Enterprise, Education, Research, Finance, Fiscal and Social Policies as well as to other pertinent and timely issues.



# Civic Participation in **European Governance &** The Plus Europe Association






The Plus Europe Association acts as a bridge between citizens and European Institutions. It primarily works with committed citizens within business and profesional sectors through nationally organized networks across Europe.

In each country, a National Committee (NATCOM) serves to identify entities with shared ideals in hopes of creating coordinated national networks of committed citizens and civic entities.

National Committees have a primary role in the preparation of the Annual Conference and the selection of Proposals for Action. They are in communication with the European Organizing Committee (EUROCOM) and the General Secretariat as well as with other National Committees relaying information and best practices from their respective networks.







# Civic Alliances and **The Plus Europe Association**



The Plus Europe Association forges alliances, as an honest broker, between civic entities and European institutions by pushing reform for new roles for the citizen outside of the normal framework of casting a vote every election year.

The Plus Europe Association envisions having future alliances with other civic entities, such as European Chambers of Commerce and Savings Banks, among others.

European Chambers of Commerce defend General Business Interests and constitute a network of talented people throughout Europe and the rest of the world.

European Savings Banks have traditionally served the communities in which they originated by financing families and small and medium sized companies and through reinvesting in civic initiatives.

These civic institutions provide services to citizens and therefore, The Plus Europe Association wishes to collaborate with them









# The Plus Europe Conference The annual Civic Meeting Point



The Plus Europe Conference is an Annual Meeting that takes place every spring. It is jointly organized by Plus Europe, selected European Rotary Clubs and Chambers of Commerce as well as other civic entities.

The conference focuses mainly on four basic areas:

- European Governance
- European Financial Convergence
- European Fiscal Harmonization
- European Social Policies.

The goal is to generate debates oriented to the consolidation of a European Governance Model and to provide relevant documents in this respect.

The Second Plus Europe Conference will take place in Brussels, at the Committee of the Regions (Bâtiment Jacques Delors. Rue Belliard 99-101).

The advancement towards the Banking Union is considered a major achievement of the EU. For the future, however, the citizen's perspective, as its service user, is also to be analysed.





#### **Call for Actions**

A call for proposals will be launched yearly by the Plus Europe Advisory Board to welcome initiatives, studies, proposals from European citizens, civic entities, academics, etc.



#### **Recommendations to European Institutions**

The debates, conclusions and recommendations of the conference will be analysed and forwarded to European policy-makers, as a civic contribution to EU policy-making.

#### Collaboration **Agreements** towards the **European Civic Alliance**

Plus Europe will gather the members of the European Civic Alliance, who, with a joint agenda, will work together to achieve greater role of the citizen within European governance

# Summary of the **First Plus Europe Conference Barcelona, February 2013**

The President of the Chamber of Commerce of Barcelona, Mr. Miquel Valls; the former Spanish Foreign Minister and current President of 'Cercle d'Economia', Mr. Josep Piqué; University Professors; The Rotary Foundation Trustee, Mr. Julio Sorjus, as well as various European RI District Governors together with 150 Rotarians were present to discuss these topics.

Three former Politicians, Mr. Joan Rigol, Mr. Carles Gasòliba, and Mr. Manuel Milian Mestre gave their insight on governance.

Keynote Speakers representing the European Commission were: Ms. Elena Flores, Director of Policy Strategy and Coordination at the DG for Economical and Financial Affairs, Mr. Xavier Prats-Monné, Deputy DG for Education and Culture, and Mr. Ferran Tarradellas, Director of the EU Office in Barcelona.

Representatives of ten Foreign Consulates accredited in Barcelona were also present as Observers.

At the closing session, the Barcelona Plus Europe Declaration was presented to the audience.

# The Barcelona Plus Europe Declaration



In a moment of uncertainty about the future of the Europe, the persons gathered at the Closing Session of the First Plus Europe Conference hereby make the following

#### **DECLARATION**

- 1. That a better European Union, not only is possible, but it is to be achieved urgently right now.
- 2. That European citizens have to construct their future; Indirectly, through political parties, but also directly through their own initiatives.
- 3. That a new civil entity to be named Plus Europe shall coordinate the working documents that will contribute, year after year, to the advancement of the European Union.
- **4.** That the Plus Europe Conference shall take place every year, as a meeting point for all citizens and civil entities who share similar ideas and the same objective: the advancement of European Union.
- 5. That Plus Europe shall work in close collaboration with European Union Institutions: The Commission and The Parliament. It will present recommendations proposing an integrated approach to European Governance, in such key issues as Education, Research, Health, and Free Enterprise, among others.
- 6. That Europe's Consensus Governance Model will likely contribute to world peace processes that are only to be achieved with the active participation of solid and transparent civic entities that do not yield to vested interests.
- 7. That Europe, the world's largest Freedom area, must exert its leadership not only through its political representatives, but through its civic entities as well. Plus Europe shall be one of them, with European Rotarian Clubs, Chambers of Commerce, and other entrepreneurial and professional associations as its main stakeholders.
- **8.** That Plus Europe shall propose recommendations designed for quick implementation. This very first Plus Europe Conference has been one example. The Plus Europe Conference will continue for years to come and will have this Declaration as a guideline for future activities.
